## Idea assessment criteria

---

1. Alignment with existing SA Health services, projects and vision
2. Uniqueness and value of the idea relative to the anticipated cost of delivery
3. Does the supplier have the resources, capability and capacity to support progression of the idea?
4. What would be the resource and capability requirements for SA Health to support progression of the idea?

## Submitting an idea

---

Suppliers are invited to register and submit ideas via the Healthy Ideas Portal.

Ideas are requested to be submitted by 31 January 2020.
